#### 1.1 IT Security Logs - Specific Processing

As part of our information systems security and to meet cybersecurity requirements, we automatically collect and retain the following logging data:

## Types of logs collected:

- Connection logs: email address and timestamp of connections/disconnections
- Administrative action logs: actions performed by administrator users on other user accounts (creation, consultation, modification, deletion)
- Navigation logs: pages visited associated with your email address

**Purpose:** IT security, intrusion detection, security audit, compliance with cybersecurity requirements

**Legal basis:** Legitimate interest (Article 6.1.f of GDPR) - Our legitimate interest in protecting our information systems and ensuring the security of the platform and its users

Retention: 12 months, then automatic deletion

**Access:** This data is accessible only to authorized technical and security teams of TotalEnergies Lubrifiants S.A.

### 2. Recipients of the data

In order to process your personal data according to the Charter, your personal data may be communicated to one or more of the data controller's departments or to TotalEnergies company subsidiaries and one or more partners, independent distributors or subcontractors: Software publisher provider
